**Equipment Failure:** Should equipment failure occur during your event you will only be charged for the bags of ice used at your event and a refund will be issued to you for any unused bags as soon as possible.

**Hold Harmless and Indemnity:** The customer is responsible for paying the full amount of services as shown in this agreement and assumes responsibility for all bags of ice delivered to the event, and agrees to release Party Ice Company, it’s agents and labor staff from any liability to anyone who may be injured in any way as a direct or indirect contact with the product delivered by Party Ice Company both during and after your event, except claims resulting from negligence or willful misconduct of Party Ice Company.

**Amendment:** This service agreement may be modified or amended in writing if signed by the party obligated under the amendment.

**Governing Law:** If any conflict shall arise between the parties the law shall be interpreted according to the laws of the State of Louisiana.
